

Sec. 16-27. Water Rates.

The rates and the charges for the use and service of the water system for the city shall be based on the minimum charges or the amount of water supplied to the user by the city waterworks system as shown on the meter readings for each month. (a) There are hereby established rates and the charges for the use and service of the sewerage system of the city. Such rates shall be based on the minimum charges stated or the amount of water supplied to the user by the city waterworks system as shown on the water meter readings for each month as follows:

(1) For system users who are water customers, the rate shall be:

a. *Residential rates:*

1. <i>Inside city:</i>		
i. First 1,000 gallons	\$27.59	<u>\$28.00</u>
ii. Over 1,000 gallons, per 1,000 gallons	\$4.96	<u>\$ 5.03</u>
2. <i>Outside city:</i>		
i. First 1,000 gallons	\$34.49	<u>\$35.01</u>
ii. Over 1,000 gallons, per 1,000 gallons	\$6.21	<u>\$ 6.30</u>

b. *Commercial rates:*

1. <i>Inside city:</i>		
i. First 1,000 gallons	\$27.59	<u>\$28.00</u>
ii. Over 1,000 gallons, per 1,000 gallons	\$6.28	<u>\$ 6.37</u>
2. <i>Outside city:</i>		
i. First 1,000 gallons	\$34.49	<u>\$35.01</u>
ii. Over 1,000 gallons, per 1,000 gallons	\$7.86	<u>\$ 7.98</u>

c. Amounts charged for the first 1,000 gallons are minimums regardless of the usage.

(2) For those who use the sewerage system but not water, the rate shall be as follows:

a. *Residential rate:*

1. Inside city, per month.....	\$89.71	<u>\$ 91.06</u>
2. Outside city, per month	\$108.27	<u>\$109.89</u>

b. *Commercial rate:*

1. Inside city, per month.....	\$116.55	<u>\$118.30</u>
2. Outside city, per month	\$145.69	<u>\$147.88</u>

(b) All potential users required by this article or by state law or regulation to connect to the system shall be charged the appropriate monthly user charge regardless of whether or not their structure is actually connected to the system.

(c) Exemptions from sewer charges shall be as follows:

- (1) Users that have a separately metered ice machine shall not be subject to sewer charges for water used in this machine.
- (2) Users that have a separately metered irrigation system shall not be subject to sewer charges for water used in this system.
